- Potential to deliver a high quality, modern, and fit for purpose building




### A SPACE TO GATHER

### A NEW HOME FOR CRICKET


- Potential to enhance the existing cricket ground and outfield

- Potential to encourage additional members, a junior team and a female team with new facilities provided in the community hub building






## OPPORTUNITY TO EXPAND VILLAGE OFFER

### LOCAL ENVIRONMENT


- Potential to provide for walking and cycling routes and connections


## ENABLING RESIDENTIAL DEVELOPMENT
